



10 Year Limited Warranty

Classic Home Elements takes great care in the craftsmanship and the selection of materials which go into each Paradise Outdoor Kitchen that we make. Accordingly we offer the following warranty:

Except as described below, we warrant to the original consumer purchaser that Paradise Outdoor Kitchens will be free from defects in workmanship and materials for Ten Years to the original registered buyer.

Within the warranty period, Classic Home Elements will repair or replace any defective materials at no charge when purchased through an authorized dealer.

This warranty does not apply to cabinets which are misused, abused, neglected, changed or modified in any way, improperly installed or improperly stored. It does not cover the cost of removal of defective material or transportation and installation of replacement material. Components not manufactured by Classic Home Elements (such as hinges, hardware, drawer glides, screws, etc.) will carry a 5 year warranty from the original manufacturer.

Due to the nature and characteristics of natural wood and natural stone, shrinkage and expansion of doors and drawer fronts are not covered by this warranty. Differences in wood/stone tones, colors and/or beauty marks from one wood/stone part to another are considered a natural characteristic of wood/stone and are excluded from any warranty coverage. Stone countertops are excluded from any warranty coverage. Discoloration and/or fading due to sunlight and or man made lighting, damages due to food and/or cooking stains, improper use of cleaning products, waxes and natural oils are also not covered by this warranty. Tuscan Teak™ parts are warranted for 5 years. To maintain this warranty, our protectant MUST be applied a minimum of twice every 12 months.

THIS WARRANTY IS THE EXCLUSIVE WARRANTY GRANTED BY CLASSIC HOME ELEMENTS AND IS IN LIEU OF ALL OTHER WARRANTIES EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND IS FURTHER LIMITED TO REPLACEMENT OR REPAIR OF DEFECTIVE PARTS OR MATERIAL ONLY. LABOUR CHARGES OR DAMAGE INCURRED IN INSTALLATION, REMOVAL, REPAIR OR EXCHANGE AS WELL AS INCIDENTAL AND CONSEQUENTIAL DAMAGES CONNECTED THEREWITH ARE EXCLUDED AND WILL NOT BE PAID BY CLASSIC HOME ELEMENTS.

Classic Home Elements does not authorize any dealers or any other person to change or alter the forgoing warranty, nor does it authorize any other person to assume additional liabilities arising from the sale of Paradise Outdoor Kitchens by Classic Home Elements. This warranty gives you specific legal rights; you may also have other rights which vary from state to state.

Every customer is required to register as being the original consumer purchaser and is essential that the "Job Name" on the original order submitted by the dealer to Classic Home Elements is the name of the actual home owner (consumer purchaser), and not the name of the contractor, construction company or designer/decorator.

No credit will be issued without the return of the defective piece, part or material. Credit for returned goods will only be issued after inspection by Classic Home Elements.

To obtain performance under this warranty you must contact the dealer from whom you purchased your Paradise Outdoor Kitchen cabinetry and report the nature of all defects claimed.
